
Diversion Program Requirements



Bicyclist Traffic Citation Diversion Program

The Lake Forest Police Department actively enforces ALL traffic laws and strives to educate and promote traffic safety to all who travel within the City of Lake Forest. To further this objective, the Lake Forest Police Department is partnering with the *League of Illinois Bicyclists*® to promote bicycle safety and education through a Bicyclist Traffic Citation Diversion Program.

Per the Illinois Vehicle Code (625 ILCS 5/11-1502), **TRAFFIC LAWS APPLY TO PERSONS RIDING BICYCLES.**



You have been observed committing a traffic violation while operating a bicycle on a public roadway within the City of Lake Forest. You have been issued a ***temporary written warning***, in lieu of a formal traffic citation. ***Without further action on your part within the next thirty (30) days, a traffic citation will be issued to you for this violation.***

Please note, traditional traffic citations for moving violations are adjudicated in Lake County traffic court and can result in a conviction on your driving record carrying a minimum fine of one hundred twenty dollars (\$120).

To avoid the issuance of a traffic citation and to take advantage of this diversion program, bicyclists who have been issued a written warning for a traffic violation are directed to the *League of Illinois Bicyclists*® website at: www.bikesafetyquiz.com to complete a quiz.

Teenage and adult violators must complete the **Adult Bicyclist, Bronze Level** quiz, then print the certificate of completion at the end of the quiz. You must email the certificate of completion to: BikeSafety@cityoflakeforest.com within 30 days of the warning citation issuance. Successful completion of the quiz and emailing of the certificate fulfills the requirements of the Bicyclist Traffic Citation Diversion Program, and no further action is required of you.

If you opt not to complete the diversion program within **thirty days (30)** of the date of issuance of the warning, a notice to appear traffic citation will be issued to you via US mail with a traffic court date for your appearance in Lake County court.
